Further to our announcement on 19 January 2018, the Board of Directors of Comcorp wishes to announce additional information of the Letter of Intent ("LOI") entered into with Thanh Cong cooperative (Enterprise Code: 0012TX) ("Thanh Cong") of which the details are as follows -

1. The duration of LOI and tentative timeframe to enter into the definitive agreement to award the contract to GWM is within twelve (12) months from the date of LOI which is 17 January 2018.
2. The licences and/or approvals required from the relevant authorities in Vietnam in the event of the award of contract to GMW shall be obtained by Thanh Cong. GMW is only required to apply for a construction licence. GMW is in the process of applying for the construction licence.
3. Thanh Cong was awarded a MSW treatment investment certificate by the People's Committee of Hanoi City on 21 November 2011.
4. The tentative duration for the operation and maintenance contract to be awarded to GWM for the Project is twenty (20) years after the completion and commissioning of the plant.
