Further to our announcements dated 13 May 2020, 30 March 2020, 17 March 2020, 10 February 2020, 14 January 2020, 25 June 2019 and 17 April, 2019 regarding the winding up of Comintel Sdn Bhd (Company No. 129234-K) [In Liquidation] ("Comintel"), a wholly-owned subsidiary of Comintel Corporation Bhd ("Comcorp") by the Shah Alam High Court on 17 April 2019 [via Companies (Winding Up) Petition No. BA-28NCC-388-07/2018], the Board of Directors of Comcorp wishes to announce that at the hearing today before the Judge at the Shah Alam High Court, the Judge allowed the application in the following terms:

1. The winding up of Comintel Sdn Bhd [Company No.: 198401016676 (129234-K)] ("Comintel S/B") pursuant to an Order For Winding-Up by the Court dated 17.04.2019 ("Winding

Up Order"), shall be terminated.

2. Without limiting the generality therein, the following consequential orders and/or directions shall be made:

(a) Comintel S/B shall cease to be in liquidation;

(b) Augustine a/l T.K. James ("Liquidator") shall cease to hold office as Comintel S/B Liquidator.

(c) Leng Keng Hok @ Lim Keng Hock (NRIC No.: 460308-04-5115) and Samshuri Bin Arshad (NRIC No.: 420505-01-5517) shall resume their full authorities and rights existed as

directors prior to the Winding Up Order.

(d) An office copy of every Order made under Sections 492 and 493 of the Companies Act 2016 shall be lodged by Comintel S/B with the Registrar of Companies and the Official

Receiver, and served to the Liquidator within fourteen (14) days from the making of this Order;

3. Costs of and incidental to this application shall form part of the costs, charges and expenses of Comintel S/B's winding up.

4. The parties be at liberty to apply.
